4. Approval of Minutes

Regular Meeting – March 16, 2020 Fogle Motioned, Caldwell Seconded

Fogle moved to approve the minutes of the Regular Meeting of March 16, 2020. The motion was seconded by Caldwell and passed unanimously.

5. Discussion / Action Items

• Commercial Rent Assistance Grant Program

Hawkins presented a draft of the Commercial Rent Assistance Grant Project and reviewed how it was created, how other DDAs were approaching this type of issue and reviewed that the LDP was in support of making a \$150,000 loan to the City of Loveland to create the debt needed to use the DDA Special Fund for this project. Hawkins said he would need a small committee to review the applications and advise on a final recommendation back to the DDA Board of Directors. Hawkins suggested Abby Powell from the LDP join this effort and Steve Olson had also volunteered at the LDP Meeting. Caldwell, who said he would not apply for funds, said he would join the review effort as well and emphasized the need to keep application submittals confidential. Hawkins also recommended Jim Cox from LDP and Ray Streele, Jr. to avoid any potential conflicts of interest.

Fogle motioned to create a review committee cosisting of Hawkins, Powell, Caldwell, Steele Jr., Olson and Cox. Waneka seconded the motion and it passed unanimously.

Back to the proposal, Directors wanted an understanding from Moses Garcia about conflicts of interest which Garcia explained in detail. Fogle requested adding CBD shops to the list of ineligible businesses. Waneka and Patterson both spoke of the need to do outreach to landlords about their efforts to join our program. Wyrick offered to assist in reviewing application questions to ensure we learn key details about the businesses financials. Krchmarik offered to review the final list of approvals against applicants to ensure they are current on sales tax.

Patterson asked if approving this program would have any effect on our future financial stability for future projects. Hawkins noted the financial presentation Alan Krchmarik gave several months ago and the revenues projected. Krcmarik noted that he agreed that we have enough financially to fund this effort and get the Banner Building project up and running.

Fogle moved to recommend that the City of Loveland (1) approve the Loveland Downtown District Commercial Rent Assistance Program as a development project authorized under the Plan of Development, (2) fund such development project through a loan from the LDP to the City, and (3) repay the LPD from the City's special fund that holds the DDA tax increment. Wyrick seconded the motion and it passed unanimously.
