#### 5. Discussion / Action Items

#### 2020 Budget Amendment

Hawkins presented an amendment to the City of Loveland's 2020 DDA Budget that adds the \$150,000 expenditure for the Commercial Rent Grant Program. The DDA Board approved a 2020 budget or \$87,115 last fall thinking the only project we may pay for in 2020 would be debt service on the 4<sup>th</sup> and Garfield project. This amendment would create room to spend to spend funds on both projects if needed.

Wyrick moved to approve Resolution R-1-2020 approving the revised 2020 budget for the Loveland Downtown Development Authority (DDA). The motion was seconded by Fellure and passed unanimously.

#### Rent Assistance Grant Project

Hawkins presented the recommended slate of grant awards for the Commerical Rent Grant Project. The review committee had met the week before discuss this list and Hawkins and Council alternate Steve Olson reviewed the financial information presented by each applicant. Overall, the list totals awards to 30 businesses of \$141,000. Hawkins noted that he had presented the recommended award list to the City of Loveland finance department to ensure that folks were up to date on their sales tax liabilities. There were four businesses that were behind and Hawkins would work with them to get them up to date before making their award.

Fogle moved to approve the presented slate of awards for the Commercial Rent Assistance Project and authorize the Executive Director to execute payments in the program. The motion was seconded by Patterson and passed unanimously.
