4. Approval of Minutes

Regular Meeting – October 5, 2020

Steele moved to approve the minutes of the Regular Meeting of October 5, 2020. The motion was seconded by Bernhardt and passed unanimously.

5. Discussion / Action Items

Cleveland Station Reimbursement Agreement Update – Hawkins updated the board on the status of the Cleveland Station Agreement. If completed in the next week, Hawkins hoped to call a special meeting to review the project in detail. The last items to be completed in the project include updating the final budget and the possible completion of an amortization schedule at the developer's request.

975 N. Lincoln Request – Hawkins reminded the board of the DDA's TIF policy for investing in projects. One way is bonding to provide immediate assistance to a project and the other was to share back TIF proceeds generated by the project. The DDA has received an application for the redevelopment of a former Chase Bank drive-thru at 975 N. Lincoln Avenue to turn into a retail coffee location. Hawkins presented a way the DDA could provide assistance to cover the cost of sidewalk improvement by sharing back half of the sales tax

generated over a period of 5-6 to the developer to cover the cost. This performance-based incentive would require no debt issuance or would also provide immediate funding to the DDA. All the growth in property tax would go the DDA. The board expressed their support of this path. Hawkins reported that we would work on a term sheet for the project and present at an upcoming board meeting.

LURA / IGA Update- City Manager Steve Adams updated the board on the progress of a draft agreement to share tax increment proceeds and a presentation of financial data on the performance of the DDA & LURA. The City Manager agreed to bring this information for a discussion on December 14th.

6. Project Updates

Façade Program- Hawkins updated the board on the status of recent Façade Inquiries. He expects that we will be reviewing applications for the 124 East 4th Street and 243 East 4th Street in the near future and is working on scope of works for two projects on 5th Street.
